Short Bio:

Mario Solís is Philosophy professor and Director of the Graduate Program in Philosophy at the University of Costa Rica (UCR) where he currently teaches moral and political philosophy. He holds a PhD in Philosophy from the University of Essex, UK. He has served as a visiting researcher at the Uppsala University, Sweden, and a Visiting Research Associate at UCL, London, UK. His interests include global justice, human rights, and moral and political philosophy. He has published several articles on issues of justice, equality and development ethics (including the entry on Latin America in the *Routledge Handbook of Development Ethics*, 2019). Solís is the author of *Justicia Situacional: Racionalidad, Normatividad y Teoría Crítica Latinoamericanista*, 2016 [Situational Justice: Rationality, Normativity and Latin American Critical Theory], which advances what he calls a "situationist approach to justice", an approach to the normativity of justice "crafted" from situations to the rest: to context, to community, to principles, to normativity as such. He is a member of the International Development Ethics Association (IDEA) and currently serves as member of its executive board. He is also part of the Instituto de Investigaciones Filosóficas, UCR (the Research Committee), as well as the Asociación Latinoamericana de Filosofía Analítica (ALFAn) and the UK-Latin America Network for Political Philosophy (UKLANPP).
